Targeting officials of the corporation for failing to collect taxes, he said that property tax collection is ₹860.67 crore till January 9 which is very less than that of the target of ₹2710 crore set for 2018-19. "Approx ₹1,000 crores property tax is due on various Government and semi-Government bodies such as Delhi Development Authority (DDA), Delhi Milk Scheme, Indian postal Services, Northern Railway, NDPL etc but no step has been taken to recover the amount.

Hitting out at the ruling BJP for failing to curb diphtheria disease, he said that the responsibility of the health department of the corporation is not limited to the prevention of diseases like dengue, malaria and chikungunya.

"It is a matter of shame for the corporation as 532 patients of diphtheria were admitted in Maharishi Balmiki Hospital in the year 2017-18, out of which 98 patients died and from 1st April, 2018 to 24 September, 325 patients of diphtheria were admitted and 46 of them died," he added.

Sitharaman meets family of late Squadron Leader

Defence Minister Nirmala Sitharaman on Tuesday met the family members of Squadron Leader Sameer Abrol who lost his life in fighter plane crash in Bengaluru on Friday.

"The Defence Minister reached Gandhi Nagar residential colony where parents of Sameer lives around 2:30 PM and stayed there for 20 minutes. She consoled the parents and wife of the deceased pilot and left for Delhi," said Himanshu Gautam, Additional District Magistrate (ADM), Ghaziabad city.

Two senior pilots were killed after they ejected from a Mirage 2000 fighter during its take-off run at the Hindustan Aeronautics Limited (HAL) runway in Yemalur in Bengaluru on Friday morning.

The pilots had been identified as Squadron Leader Sameer Abrol and Squadron Leader Siddhartha Negi.

Sameer belonged to Ghaziabad and his body was brought to his home on Saturday for last rites. He was cremated at cremation ground on Sunday where the former Chief of Army staff General (retd.) VK Singh who is local MP and Union Minister of

State for External Affairs paid tribute to the departed soul.

In addition to VK Singh the local MLA and State Minister in UP Atul Garg, local politicians and social activists were present to pay their tribute to the departed soul. A guard of honor was given to Air Force officer at the Hindon cremation ground where the officer's body was laid to rest full state honours.
